Take I-95 S toward BENSON / FAYETTEVILLE.
Take the NC-82 exit- EXIT 65- toward GODWIN / FALCON.
Turn LEFT onto GODWIN-FALCON RD / NC-82 / GODWIN FALCON RD.
Turn LEFT onto SHERRILL BAGGETT RD. 0.7
Turn RIGHT onto BEND OF THE RIVER RD.
Field half mile on left.

From the South:

Take I-95 N toward FAYETTEVILLE
Take the NC-82 exit- EXIT 65- toward GODWIN / FALCON.
Turn SLIGHT RIGHT onto GODWIN-FALCON RD / GODWIN FALCON RD / NC-82.
Turn LEFT onto SHERRILL BAGGETT RD.
Turn RIGHT onto BEND OF THE RIVER RD.
Field half mile on left.

From Charlotte, NC:

Take I-40 E toward RALIEGH.
Merge onto I-95 S via EXIT 328A toward BENSON / FAYETTEVILLE.
